Cllr Deaville reported he had noticed a damp mark on the floor in the hall and had also noticed that there was some frost damage to one of the gargoyles on the roof. After the recent spell of rain, he re-inspected the hall and found that the floor was dry. He considers the frost damage to the gargoyle may be due to the felt on the roof not going into the guttering and causing the water to run down the gargoyle which froze in the cold weather period last month.
